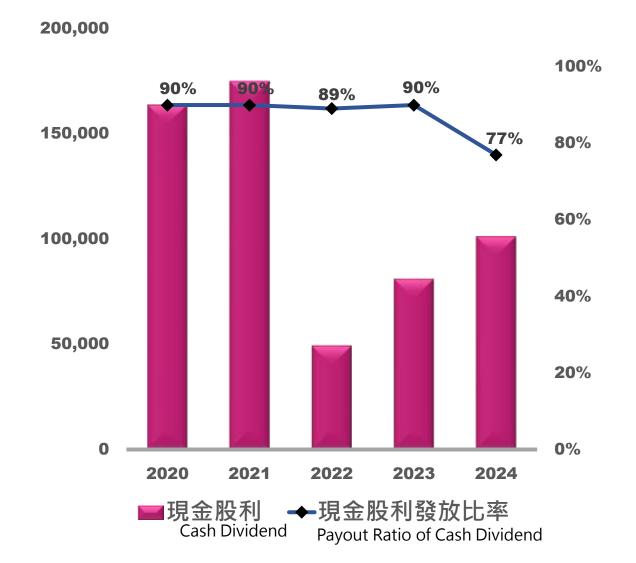


- 1. The Company has completed the acquisition of Sanyou Beauty & Wellness Marketing, Ltd. in April, 2022. The reorganization under common control is deemed to be a merger from the beginning. Therefore, the related amount of FY2021 was restated.
- 2. Simple Mart Investment Co., Ltd. invested in Pet Wonderland Co., Ltd. in September 2024 (acquisition Date) and actually acquired 51% of the equity in the first phase. The financial statements were accounted for using the prospective acquisition method of 66% in accordance with the accounting policy.
